This is a Contract between Dog Pawz, LLC stayNplay (Pet Care Facility (Dog Pawz)) and the pet owner set forth above whose signature(s) appear below (hereinafter called Owner):

1. Owner agrees to pay the rate for daycare/boarding in effect on the date pet is checked out of the Pet Care Facility (Dog Pawz).
2. Owner further agrees to pay all costs and charges for special services requested and all veterinary costs for said pet while in the care of the Pet Care Facility (Dog Pawz).
3. Owner further agrees that the pet shall not leave the Pet Care Facility (Dog Pawz) until all charges are paid to said Pet Care Facility (Dog Pawz) by Owner.
4. By signing this Contract and leaving his/her pet with the Pet Care Facility (Dog Pawz), Owner certifies to the accuracy of all information given about said pet. Owner further understands and agrees that in admitting pet(s) is/are in good health and have not harmed or shown aggressive or threatening behavior toward a person or dog.
5. The Pet Care Facility (Dog Pawz) shall exercise reasonable care for the pet delivered by the Owner to the Pet Care Facility (Dog Pawz) for daycare, cage-less overnight, or grooming. Owner further understands and agrees that Dog Pawz, LLC playNstay and its staff and volunteers will not be liable for any problems which develop, provided reasonable care and precautions are followed, and Owner hereby releases them of any liability of any kind whatsoever arising for pet(s) attendance and participation at the Pet Care Facility (Dog Pawz). It is expressly agreed by Owner and Pet Care Facility (Dog Pawz)'s liability shall in no event exceed the lesser of the current value of the pet of the same species or the sum of 500.00 per animal cared for. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the Pet Care Facility (Dog Pawz). Owner further understands and agrees that any problems which develop with Owner's pet(s) will be treated as deemed best by staff and volunteers of Dog Pawz, LLC stayNplay, at their sole discretion, and that Owner assumes full financial responsibility for any and all expenses involved.
6. Owner specifically represents that s/he is the sole owner of the pet, free and clear of all liens and encumbrances.
7. Owner specifically represents to Pet Care Facility (Dog Pawz) that the pet has not been exposed to any communicable diseases/viruses within the last thirty (30) day period prior to boarding.
8. All charges incurred by Owner shall be payable upon pick-up of pet or at Pet Care Facility (Dog Pawz)'s choice when billed by Dog Pawz, LLC playNstay at address listed above. The Pet Care Facility (Dog Pawz) shall have, and is hereby granted, a lien on the

pet for any and all unpaid charges resulting from boarding, daycare, or grooming at Dog Pawz, LLC playNstay. The Owner hereby agrees that in the event the daycare, cage-less overnight, or grooming charges are not paid when due in accordance with this contract, Dog Pawz, LLC playNstay may exercise its lien rights upon three (3) days written notice given by Dog Pawz, LLC playNstay to Owner by certified mail to address shown on contract. Dog Pawz, LLC playNstay may relocate/adopt of pet for any and all unpaid charges, at private or public sale, in the sole discretion of the Pet Care Facility (Dog Pawz), and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of board, daycare, or other delinquent charges, plus cost of sale, then Owner shall be liable to Dog Pawz, LLC playNstay for the difference and legal fees. All monies realized by the Pet Care Facility (Dog Pawz) at such sale, over and above the charges due and cost of sale, shall be paid by the Pet Care Facility (Dog Pawz) to Owner.

9. If pet becomes ill, requires professional attention, the Pet Care Facility (Dog Pawz), in its sole discretion, may engage the services of a veterinarian or administer medicine or give other required attention to the animal and the expenses thereof shall be paid by the Owner.
10. If pet is in Pet Care Facility (Dog Pawz)'s care and fleas are found, Pet Care Facility (Dog Pawz) will provide flea treatment with a \$35.00 charge added to Owner's bill.
11. FEES: If a pass is purchased, it is valid for twelve (12) months from the date of purchase and is non-refundable.
12. Boarding reservations during holiday/peak pricing must be cancelled within 48-hours. All boarding reservations during holiday/peak pricing require a valid credit card to be held electronically on file. Failure to cancel a boarding reservation during holiday/peak pricing will result in a \$38.00 no call-no show fee.
13. This contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives, and assigns of the Pet Owner and Dog Pawz, LLC playNstay.
14. Boarding requires a credit card on file at time of the reservation.
15. Owner hereby certifies that pet(s) is/are in good health and have not been ill with any communicable condition in the last thirty (30) days. Owner further certifies that dog(s) have not harmed or shown aggressive or threatening behavior toward any person or any other dog. Owner has read and understands the foregoing.
